- 1. Survey results: Members commented on survey holes. Board & GM replied.
- 2. Pool repair, groundwater damage, mitigation costs and funding plan. (loan, dues increase, special individual assessment, or other) Feedback from meeting with different contractors. \$245,000 allotted in current Reserve funds but may cost more for unforeseen ground water mitigation repairs. (Staff recommendation to seek bids from an engineer based upon board's decisions on scope of project). –GM presented pool, shed, and ground water issues. Member and board extensive discussion. Charge non-residents, but have to be 100% ADA compliant. Get RFPs then do survey. Set info out at pool. Do soils report first, then RFP (multi options 1. Groundwater, replace as is, replace and enhance). Clear direction to GM for multi option RFP.
- 3. Open space management fire prevention. Annual assessment increase to fund defensible space clearing on GDRA properties. Approx \$5.50 per year per parcel based on 8 year treatment program at \$1200 / acre for treatment of approx. 50 acres over a 8 year period. CA code 4291. May be partially offset if grants become available (Have lowered acreage estimates by half from last meeting brush only, no grass mitigation). GM presented to do brush only. Board and GM discussed.
- 4. Candidate forum: This time is to be used for board candidates to answer questions from members of the Association. Candidates introduced and spoke about themselves. Community questions were posed to candidates. All candidates replied to each question.
- 5. 2015 Budget workshop and review. New Reserve study funding. CC&R on allowable assessment increases laws on borrowing from reserves, banks and current bank loan rates and payback. Board directed staff to revise budget with a 20% annual assessment increase
