- 3. Review of request for variance of rule 2.03(c)(4)(5) by owner of unit 3 lot 040 (fence location): Discussed and approved.

VII. Workshop and discussion:

- Allowances to trim willows/ trees / brush in green belt areas for aesthetics. Discussion of Green Belt
 Management Program: Discussed having an oversight/consult from wildlife biologist re: impacts to wildlife and
 open space before moving forward with trimming willows. Need drawing re: how willows will look. Get quotes
 from naturalist.
- Possible sale of 10506 Manchester GDRA surplus lot: Owner of next door lot, present and commented.
 Discussed options. Board would like to go view the lot. Board not ready to make decision on this until more research done on lot line adjustment, etc. Owner of next door lot to give proposals for solutions.
- 3. Possible trail funding program: Allison Pedley with Truckee Trails Foundation presented on how to maintain growing system of class 1 bike paths, Legacy Trail, etc. Finishing LT to Donner Lake through public financing, possibly sales tax increase, TOT etc. Discussed a GDRA board member to be on steering committee and gauge how Glenshire community stands on this.
- 4. Glenshire Elementary Parking Expansion, possible grant of land to school: John Britto from Town TTUSD presented and requested to use and be responsible for GDRA common space for parking, starting construction in 2015. Britto requested to know if board supports lot line adjustment so they can begin moving forward with research and plans. Board is pretty much in favor. TTUSD will re-connect in the spring.
- Green bags: Future of program and an acceptable part of our community or enforceable under CC&R 6.15 / 8.08: Board thoughts: Explore other alternatives, in favor because it helps with defensible space; have town charge for more than 4 bags per week; get rid of 4 bag limit.
- 6. Long term storage of motor homes / trailers. When do they become a "shed" an Architectural improvement as defined by Article V. or CC&R 8.04 "Temporary structure such as a trailer": Deferred to next meeting.
- 7. Town of Truckee exterior lighting code 18.30.060 CC&R 6.10. Dark Sky lighting. Finding the correct definitions of these three: Deferred to next meeting.
- 8. Owner asking for an extension to CC&R 6.04: Deferred to next meeting.
- Open space standing dead tree complaint: Reviewed and discussed: Board directed to: Invite complainant to remove tree; wait and see if we can get defensible space clearing grant or have funds in defensible space fund. Discussed another tree as well.

- 10. Board Retreat/Planning Meeting: 100% attendance speak with Seana and Lauren about their knowledge of Glenshire. Board agrees to spend in the upper end of guote and to hold on a Sunday.
