# **Outdoor Grilling** Safety Tips

Summertime is filled with fun family activities outdoors. Outdoor grilling is one of the most popular ways to cook food during the summer months. But, a grill placed too close to anything that can burn is a fire hazard. They can be very hot, causing burn injuries. Follow these simple tips and you will be on the way to safe grilling.

#### **Safety Tips**

- Propane and charcoal BBQ grills should only be used outdoors.
- The grill should be placed well away from the home, deck railings and out from under eaves and overhanging branches.
- Keep children and pets at least three feet away from the grill area.
- · Keep your grill clean by removing grease or fat buildup from the grills and in trays below the grill.
- Never leave your grill unattended.
- Always make sure your gas grill lid is open before lighting it.

#### **Charcoal Grills**

• There are several ways to get the charcoal ready to use. Charcoal chimney starters allow you to start the charcoal using newspaper as a fuel.

- If you use a starter fluid, use only charcoal starter fluid. Never add charcoal fluid or any other flammable liquids to the fire.
- Keep charcoal fluid out of the reach of children and away from heat sources.
- There are also electric charcoal starters, which do not use fire. Be sure to use an extension cord for outdoor use.
- When you are finished grilling, let the coals completely cool before disposing in a metal container.

## **Propane Grills**

- Check the gas tank hose for leaks before using it for the first time each year.
- Apply a light soap and water solution to the hose. A propane leak will release bubbles.
- If your grill has a gas leak, by smell or the soapy bubble test, and there is no flame, turn off the gas tank and grill. If the leak stops, get the grill serviced by a professional before using it again. If the leak does not stop, call the fire department.
- If you smell gas while cooking, immediately get away from the grill and call the fire department. Do not move the grill.
- If the flame goes out, turn the grill and gas off and wait at least 15 minutes before re- lighting it.

# The Great Pine Needle Debate

**Pro:** Fallen pine needles often serve as an important natural mulch, protecting bare soil from erosion. Fallen pine needles should be left in place.

**Con:** Dried, fallen pine needles are one of the most easily ignitable materials in Tahoe's forests. Fallen pine needles should be removed.

**Compromise:** In areas where dead pine needles are present, but are not covering bare soil, remove them. This includes dead needles that are still attached to trees; draped on live plants; lying on the roof or deck; covering lawn and mulches; or lying on hard surfaces, such as sidewalks, patios, and driveways. In areas where fallen needles are covering bare soil, use the following recommendations. Within 5 feet of the house and deck, remove all dead needles. Maintain a 1" to 2" layer of needles 5 feet to 30 feet all dead pine needles. For the area that lies 5 feet to at least 30 feet from the house and deck, maintain pine needles at a depth of 1 to 2 inches. Take care to avoid disturbing the "duff layer" if present, the dark area at the ground surface where needles are decomposing.

# What Is Blue-Green Algae And Why Are We Hearing So Much About It?

Blue-green algae, or cyanobacteria, are an ancient group of algae. Although they are most closely related to other bacteria, they can photosynthesize like green plants. Blue-green algae reproduce rapidly in lakes and ponds with adequate amounts of sunlight, air/water temperature and nutrients like phosphorus and nitrogen. Within a few days a clear lake or pond can become cloudy with algae growth. This is called a bloom. Algae blooms are likely to occur during sunny, calm weather when high concentrations of nutrients are present in water. The two important nutrients that can cause a bloom are phosphorus and nitrogen, found in animal and human waste and fertilizers.

#### Why be concerned?

Some kinds of blue-green algae produce natural toxins or poisons. When these algae die and break down, toxins can be released into the water. Avoid contact with blooms and dense accumulations of these algae.

#### What about Glenshire Lake?

Although Glenshire's Lake has not tested positive for a Blue – Green Algae bloom, this summer is setting up conditions that could lead to one. Eleven dog deaths since 2001 have been linked to blue green algae in Humboldt and Mendocino counties.

## What are the symptoms?

Symptoms found in dogs that have come in contact with Blue Green Algae include: vomiting, diarrhea, and seizures within


minutes or up to hours after swimming in contaminated water. If you believe your pet has been exposed, consult your veterinarian immediately. In humans similar symptoms can be experienced and you need to seek medical attention immediately if you think you may have been exposed. #### How can I tell if it's present?

It looks like thick pea soup or "spilled" green paint and can form a thick mat or a foam along the shoreline. Blue-green algae is made up of extremely small organisms that are hard to pick up and hold. In contrast, if you pick up algae and it is stringy, made up of long bright grass-green strands that feel either slimy or cottony, it is not blue-green algae, but harmless green algae.

#### What can you do to help?

Please pick up after your pet. Do not let dog feces sit in your yard and pick up immediately in public areas. Dog waste is considered a non point pollution source by the EPA. Not only does dog feces cause algae blooms it is also is a common carrier of, heartworms, whipworms, hookworms, roundworms, tapeworms, parvovirus, giardia, salmonella and E.coli.

# Truckee River Legacy Trail

The Glenshire Devonshire Association's Board of Directors has been an integral player in helping with the completion of the Truckee River Legacy Trail. Both Phases 1 and 2 of the trail were completed in the summer of 2009. These two phases link the Truckee Regional Park to the Riverview Sports Park and include connections to Easter River Street and Ranch Way. In 2010, Phase 3A of the trail was completed. This part of the trail connects the Riverview Sports Park of Phase 2 to an overlook of a historic site just west of the TTSA plant. As Phase 3B is finished, it will link the Truckee River Legacy Trail with the Glenshire neighborhood. The Trail is scheduled to be fully open by August 8th.

Once completed the Trail will connect Glenshire's neighborhood to Donner Memorial State Park, and the majority of the trail will take the user right along side the Truckee River. This key trail will enhance the quality and value of life in Glenshire. There are a variety of ways to enjoy the Truckee River Legacy Trail. Get out and take a walk, ride a bike or skate and enjoy the river. It is hard to attempt to describe the unimaginable beauty and breath-taking scenery of the Truckee River. We are fortunate to have this trail and Glenshire is poised to be the greatest benefactor of its completion.







# Wildfire Evacuation Checklist

If a wildfire approaches your neighborhood, this checklist can help you evacuate your home quickly and safely. Review this information now to prepare yourself for such an emergency. What should I wear and have with me when I evacuate?

- O Wear only cotton or wool clothes Proper attire includes long pants, long-sleeved shirt or jacket, a hat, and boots
- O Carry gloves, a handkerchief to cover your face, water to drink, and goggles
- O Keep a flashlight and portable radio with you at all times
- O Tune in to a local radio station and listen for instructions

## What about family members, pets, and livestock?

- O If possible, evacuate all family members not essential to preparing the house for wildfire
- O Plan several evacuation routes from your home

- O Make sure to designate a safe meeting place and contact person
- O Relay your plans to the contact person
- O Evacuate pets and livestock whenever possible. Never turn the animals loose
- O Contact the local Humane Society or other organizations for assistance with animals if needed

#### How should I prepare my car?

- O Place vehicles in the garage, pointing out with keys in the ignition
- O Keep vehicle fuel tank full during fire season
- O Roll up the windows
- O Close the garage door, but leave it unlocked
- O If applicable, disconnect the electric garage door opener so that the door can be opened manually
- O Place essential items in the car

O If you do not drive, make other arrangements for transportation in advance

#### What should I take with me?

- O Important documents (bank, IRS, trust, investment, insurance policy, birth certificates, medical records)
- O Credit and ATM cards
- **O** Medications
- O Prescription glasses
- O Driver's license
- O Passport
- O Computer backup files
- O Inventory of home contents (consider videotaping now, prior to an emergency)
- O Photographs of the exterior of the house and landscape
- O Address book
- O Cell phone and charger
- O Personal toiletries
- O Enough clothing for 3-5 days
- O Family photo albums and videos
- O Family heirlooms

#### How should I leave my home?

- O Close all interior doors
- O Leave a light on in each room
- O Remove lightweight, nonfireresistant curtains and other combustible materials from around windows
- O Close fire-resistant drapes, shutters, and blinds
- O Turn off all pilot lights
- O Move overstuffed furniture, such as couches and easy chairs, to the center of the room
- O Close fireplace damper

# What about the outside of my home?

- O Place combustible patio furniture in the house or garage
- Shut off propane at the tank or natural gas at the meter
- O Close all exterior vents if possible
- O Prop a ladder against the house to provide firefighters with easy access to the roof
- O Make sure that all garden hoses are connected to faucets and attach nozzles set on "spray"
- O Close all exterior doors and windows
- O Leave exterior doors unlocked
- O Turn on outside lights
- O If available and if there's time, cover windows, attic openings, and vents with plywood that is at least one-half inch thick
- O Wet down wood shake or shingle roofs before leaving
- O Fill trash cans and buckets with water and place where firefighters can find them
- O If you have an emergency water source (pool, pond, etc.) and/or portable pump, clearly mark its availability so it can be seen from the street

Be prepared! It will likely be dark, smoky, windy, and hot. There may be airborne burning embers, no power, no telephone service, and poor water pressure.

Remember, there is nothing you own worth your life! Please evacuate immediately when asked by firefighters and law enforcement officials.





# Defensible Space Zones

#### **ZONE 1**

Zone 1 encircles the structure and all its attachments (wooden decks, fences, and boardwalks) for at least 30 feet on all sides. Note: the 30-foot number comes from the very minimum distance, on flat ground, that a wood wall can be separated from the radiant heat of large flames without igniting. In this area:

- Plants should be carefully spaced, low-growing and free of resins, oils and waxes that burn easily.
- Mow the lawn regularly. Prune trees up six to ten feet from the ground.
- Fences: A wooden fence can act as
   a fuse leading right to your home.
   To lessen fire danger, don't attach a
   wood fence directly to your house.
   Instead, attach it to a cement pillar,
   a section of wire fence or a gate.
- Space conifer trees 30 feet between crowns. Trim back trees that overhang the house.
- Create a 'fire-free' area within five feet of the home, using nonflammable landscaping materials and/or high-moisture-content annuals and perennials.

- Remove dead vegetation from under deck and within 10 feet of house.
- Consider fire-resistant material for patio furniture, swing sets, etc.
- Remove firewood stacks and propane tanks; they should not be located in this zone.
- Water plants, trees and mulch regularly.
- Consider xeriscaping if you are affected by water-use restrictions.

## **ZONE 2**

Zone 2 is 30 to 100 feet from the home, and plants in this zone should be low-growing, well irrigated and less flammable. In this area:

- Leave 30 feet between clusters of two to three trees, or 20 feet between individual trees.
- Encourage a mixture of deciduous and coniferous trees.
- Create 'fuel breaks', like driveways, gravel walkways and lawns.
- Prune trees up six to ten feet from the ground.

Ask permission to create defensible space zones outside of your property and within 100' of any structure on your property.

## 2014 SWIMMING POOL SCHEDULE (weather permitting)

Open Daily Beginning Saturday, June 21 through September 1, 2014. The dates of operation for the pool generally follow the TTUSD schedule. The pool may be open on weekends after September 1 depending on weather, demand and staffing availability. Weather and safety concerns may close the pool at any time.

## WEEKDAY SCHEDULE

8am - 10am Lap Swim 10am - 12pm Swim Lessons 12:15pm – 5pm Open Swim 5:15pm - 7pm Family Swim

#### **WEEKEND SCHEDULE**

9am - 11am Lap Swim 11:15am - 5pm Open Swim 5:15pm - 7pm Family Swim

**Morning Lap Swim:** The swim lanes are reserved for anyone who wants to swim laps. Swimmers must swim continuous laps.

Open Swim: All ages. Minors not able to pass the Glenshire "swim test" must be accompanied and supervised by an adult. All children 12 years and under must be accompanied by an adult. There will be a ten-minute break on the hour between noon and 5:00 p.m.

Family Swim: This time is designed for families to enjoy the pool area. Please use this time for all Association members that are under 18 to be with an adult.

Remember, amenity privileges are reserved for Members in Good Standing. If you are unsure if you have any balances due please contact the Association offices Monday through Friday.

#### **POOL PICTURE PASS**

To use the pool, you must be a member in good standing and present a current picture pass for all family members. Proof of residency and family status is required for all renewals and new passes.

There is \$20 charge to renew passes. The pool pass office will be open weekends beginning May 24, and daily starting June 21th.
