As many know the pool and supporting infrastructure is at the ends of its 45 year life and the GDRA board has been working diligently on planning for repairs and replacement to keep the facility operational. Over the last year interested residents have been attending board meetings and giving feedback on what the pool use might look like in the future. Feedback has included how important the pool and clubhouse are to the Glenshire community.

As I write this, the pool committee is submitting ideas and the GDRA board of Directors is selecting a project manager to oversee the project. Some of the key points being looked at are: reconfiguration of the entrance to meet current ADA laws, solar heating, energy efficiency pumps and filtering systems, extended lap swimming opportunities, improved recreational swimming configuration and semi permeable deck surface.

Understanding Dark Sky Exterior Lighting Codes

I am sometimes amazed by the positive feedback I get when we can assist in something resonating with a Glenshire owner. In this case I'm speaking of the somewhat difficult to understand issue of "Dark Sky Exterior Lighting". When owners do get it, it is like the light clicks on! Often after someone changes out their light fixtures to become dark sky compliant, they thank the association because they never realized that there were any issues with their old fixtures until they were wowed by how much nicer their property looks and safer it feels with the appropriate fixtures.

Dark Sky Lighting is a code within the Town and our Association. I have to admit that reading the Association CC&R's or Town code can be difficult and full of legalize. Therefore we have set up a display area of appropriate lighting fixtures at the Glenshire Clubhouse office for your viewing, along with a list of retailers that carry some of these fixtures. To further help with the understanding of "Dark Sky Lighting" we have broken down the legalize codes to easy to understand bullet points:

- If you can see a direct exterior light source (bulb or light through glass fixture) from outside your property it needs to be covered (shielded).
- All non-essential exterior lighting shall be turned off when not in use. Lights on timers are encouraged and lights on sensors are encouraged.
- Bright, glaring and direct lighting creates safety issues, blinding you and creating shadows for criminals to hide in.
- Lighting that lights the ground makes it safer to walk by illuminating possible trip hazards. Bright direct lights blind you to possible dangerous conditions.

- Many studies have shown that bright lights are harmful to wildlife, effecting feeding, mating and more.
- Dark skies are one of the reasons most of us live in the mountains and not in the city (Los Vegas is a place better to visit).
- Proper lighting increases property values.

You can help improve Glenshire's safety, property values, mountain and wildlife environment by replacing light fixtures if needed and joining our Dark Sky Lighting committee. Please feel free to contact the GDRA offices with any questions. 530.587.6202.

Survey | TOWN OF TRUCKEE



Feedback Needed!

The Town of Truckee wants your feedback on our curbside yard waste collection program. Presently, residents set out 4 green plastic bags per week for yard waste collection. However, the Town of Truckee and Tahoe Truckee Sierra Disposal is considering recommending that the program is changed to incorporate the use of 96 gallon rolling carts instead of the green bags.

The proposed change may be presented to the Town Council for their consideration in March. If approved, carts could be phased in over two years with Tahoe Donner and Glenshire transitioning to carts beginning in May 2015. The remaining neighborhoods would begin the cart service in 2016.

Concurrently with the 96 gallon cart program the Town will continue to offer Free Drop-Off at Eastern Regional Landfill and reduced cost yard waste only dumpsters. Cell Tower In Glenshire

At the GDRA board meetings over the last year the Board had been discussing an offer by a cell tower provider who wanted to lease a 40'X40" piece of GDRA land for placement cell tower. As time progressed the company started to provide more information on exact location, height, lease amounts and other details. A Monthly amount for the lease was around \$2,000/ month for 25 years and the lease included a 5 figure initial payment. At the same time the GDRA board practiced its due diligence and directed staff to contact our attorney to ensure proper procedures were addressed before we got too far along into the process. Shortly before the January 2015 board meeting the Board of Directors learned that the tower was scheduled to be 91' feet tall. That information was posted on our Facebook page, an email was

sent out to members and the matter was placed on the board agenda for discussion. The response was amazing. Over 40 residents attended the January meeting and expressed concerns from the visual appearance to the possible health risks. In the end the cell tower company pulled out and will be looking for another location in Glenshire that is not on Association land.

The process has taught me a lot about cell towers, antennas and radio frequencies. The FCC registers 7 cell towers and 84 antennas in the greater Truckee area (a tower can have more than one antenna and antennas don't need a tower). For 4G signals rural antennas are placed about 1-2 miles apart. Certainly a lot more than I had ever thought!

With full time employees, a playground and after school programs at the Clubhouse I started looking into the health effects of cell towers. I found that cell frequencies are the same that TV has been using for the last 80 years. Although there is no conclusive evidence of negative health effects there are concerns over long term exposure and many feel that we are living in a petri dish being flooded with radio waves just waiting to see what will happen. This has been accelerated by the increase in use of electronic devices. The real health issues might be from our personal cell phones. The radio wave energy from a cell phone is 5 to 10 times higher than if you were standing 40 feet away from a cell phone antenna! The wireless router in a house for Internet is a small version of a cell tower and our close proximity to it makes our



exposure many times more than a cell tower antenna.

I found some "health concern" tips that you can do to help limit exposure:

- Children should never use cell phones. Especially while their brain is developing
- Reduce your cell phone use. Turn it off. Use it for emergencies only
- If you use your cell phone only use it where there is good reception.
- Use a hard wired land line at home for phone use. Remove your cordless phone. If you keep your cordless phone move the base station and handsets away from bedrooms
- Get rid of your wireless router and only use hard wired internet connections
- Eliminate all remote controls
- Don't use your cell phone around others. I might not care about my health, but I should be courteous of others. (Much like second hand smoke)

My research came up with about 1300 articles related to the health effects of cell towers running from "There are no issues" to "We are all going to die" to "Who cares they are just ugly". I recommend anyone interested to do their own research and keep an open mind to the information available.

- Use Fair Market Value (FMV) for the car. You can only deduct the amount that the charity sells the car for at auction as indicated on the written receipt the charity sends you.

10. Take the time to get it right.

California Paint Stewardship Program

Each year about 650 million gallons of architectural paint is sold in the United States. Did you know that about 10 percent goes unused and is available for recycling?

California's Paint Stewardship Law requires the paint manufacturing industry to develop a financially and environmentally sustainable program to manage postconsumer architectura paint. The program includes: education about buying the right amount of paint, tips for using up remaining paint and setting up convenient recycling locatior throughout the state.

PaintCare is a non-profit organization established by paint manufacturers to r the program in California and any state with a paint stewardship law.

Places to Take Old Paint

Paint recycling is more convenient with PaintCare. We set up paint drop-off sites throughout California. To find your nearest drop-off site, use PaintCare's search tool at www.paintcare.org or call our hotline at 855.724.6809.

How to Recycle

PaintCare sites accept all brands of old house paint, stain and varnish – even if they are 20 years old! Containers must be five gallons or smaller, and a few types of paint are not accepted. See back panel for a list of what you can recycle.

All PaintCare drop-off sites accept at least five gallons of paint per visit. Some sites accept more. Please call the site in advance to make sure they can accept the amount of paint you would like to recycle.

Make sure all containers of paint have lids and original labels, and load them securely in your vehicle. Take them to a drop-off site during their regular business hours. We'll take it from there.



What Happens to the Paint?

PaintCare will make sure that your leftover paint is remixed into recycled paint, used as a fuel, made into other products or properly disposed.

Who Can Use the Program?

Residents bringing paint from their home can bring as much latex or oil-based paint as the site is willing to accept.

Businesses (painting contractors and others) can use this program with one restriction: If your business produces more than 220 pounds (about 20-30 gallons) of hazardous waste per month, you may use the drop-off sites for your latex paint only and not for your oil-based paint. To learn more about this restriction, contact PaintCare.

Large Volume Pick-Up

If you have at least 300 gallons of paint to recycle from your business or home, ask about our pick-up service. Please call for details or to request an appointment.



PaintCare Recovery Fee

PaintCare is funded by a fee paid by paint manufacturers for each can of paint they sell in the state. Manufacturers pass the fee to retailers, who then apply it to the price of paint. Stores can choose whether or not to show the fee on their receipts. Fees are based on the size of the container as follows:

paintcare*

\$0.00 Half pint or smaller \$0.35 Larger than a half pint to smaller than 1 gallon \$0.75 1 gallon

\$1.60 Larger than 1 gallon to 5 gallons

Not a Deposit

The fee is not a returnable deposit – it is part of the purchase price. The fees are used to pay the costs of running the program: recycling, public education, staffing and other expenses.

Three Feet For Safety Act

California Vehicle Code 21760 requiring

three feet clearance between bicyclists and passing vehicles. The legislation, enacted as the "Three Feet for Safety Act", is intended to increase safety and awareness for bicyclists and motorists alike on public roadways.

Tips For Motorists & Bicyclists

- 3' Feet for Safety -- Give at least three feet between your vehicle and the bicyclist. Do not overtake or pass too closely a person bicycling. California law requires a standard minimum distance of three feet between any part of the motor vehicle and any part of the bicycle or its operator. Anticipate people bicycling on the roadway. Bicyclists have the right to use all roadways, same as vehicles, except in areas officially excluded, such as a freeway.
- Reduce your speed when passing bicyclists. Air pressure from vehicles passing bicyclists, especially trucks and buses, can "push" a bicyclist over from the wind created by passing vehicle at high speed.
- Watch for Bicyclists. When preparing to enter the roadway or make a turn, look carefully for oncoming bicyclists. Many bicyclists are capable of speeds in excess of 25 miles per hour.
- Have Patience. Be aware that when a lane is too narrow for vehicles and bikes to be safely side by side, a bicyclist may ride in or near the center of that lane to discourage motorists from unsafe passing.

Go with the flow – not against it. When bicycling on the road, always go with the traffic flow and ride in the same direction as motor vehicle traffic. Riding against the flow of traffic (on the wrong side of the road) is a major contributor to conflicts between vehicles and bicyclists, and typically results in serious injury or death to the



bicyclist. Riding against the traffic flow is extremely unsafe and illegal.

➔ Obey All Traffic Laws. Stop at red lights and stop signs and yield to pedestrians. Bicyclists have a right to ride on the road, same as cars but with that right comes the responsibility to obey the rules and laws of the roadway. A

bicyclist may receive a citation and fine, just like the driver of a motor vehicle.

- Be Predictable. Ride in a straight line and signal your moves to motorists, other bicyclists, and pedestrians to let them know what to expect. That is the law.
- Increase Your Visibility. Wear fluorescent or brightly colored clothing during the day, dawn, and dusk. When you ride at night, you must have a white headlight and red lights or reflectors on the back of your bike, white or yellow reflector on each pedal or a bicyclist's shoe or ankles, and side reflectors (unless the bicycle is equipped with reflectorized tires.). (CVC 21201)
- Stay Alert at All Times. Use your eyes and ears. Watch out for potholes, cracks, wet leaves, storm grates, railroad tracks, or anything that could make you lose control and fall. To be able to listen for dangerous situations, do not use headphones or earplugs in both ears while riding. (CVC 27400)
- Look Before Turning. When turning or changing lanes, always look behind you for a break in traffic, signal, and then check again before making the turn. As you approach intersections, be aware of the people behind, beside, and in front of you who may try to cross your path. Watch out for left or right-turning traffic; these are the most frequent motorist-caused bicycle crashes.
- Give and Get Respect. Allow faster traffic to pass when it's safe; avoid needlessly blocking the road.

Recycling saves money and protects the environment because improper waste management costs money – your money. You pay in higher consumer prices, taxes for environmental cleanups and increased health care costs. Protect our environment and conserve resources by taking your used oil to recycle at Truckee Rents, Truckee Automotive and Eastern Regional Landfill. Recycling used oil is FREE at all three of these locations! These kits are good for boat, car, truck, RV, snowmobile and dirt bike owners!

Free Kits Include

- 11-quart oil container Place used oil into container and drain oil filters for 24 hours. Place oil filters in a plastic bag or bucket.
- Oil-only mat Use when fueling or changing oil to prevent spills and water pollution. If a spill occurs on land, rain transports chemical through storm drains directly to our waters.
- Oil-only bilge pillow Oil and fuel collect in boat bilges and enter our waters, therefore it is important to place this bilge pillow in the bilge to absorb oil. When the bilge pillow is there, it will collect oil and prevent it from being automatically released into the water.
- Oil Funnel

What Do You Expect From Your Utility Company?

Liberty Utilities customers expect—and deserve—to have safe, reliable power.

Since acquiring NV Energy's service territory around Lake Tahoe in January 2011, Liberty has dedicated over \$2 million annually on long-overdue trimming around power poles and lines. This has significantly reduced branches and whole trees from falling on power lines causing outages, but it's not enough. While we saw outage improvements in 2012 and 2013, in 2014 Liberty's customers experienced some outages that we believe are not at acceptable levels. Although some of these outages resulted from events beyond our control (such as the December 11, 2014 storm with strong winds), we believe more preventative work needs to be done. We will continue to work hard on our maintenance tasks and continue to plan for system improvements in the years ahead. One example of those planning efforts is the current proposed rebuild of the 625 and 650 lines.


These lines are configured as part of a continuous loop that primarily serves Lake Tahoe's northern shore. They are some of the oldest power lines in the State, constructed as early as 1959. If part of that loop is adversely affected, the entire system can be impacted and can result in outages. During prior winter peaks the system has operated at maximum capacity which stresses the infrastructure and can cause subsequent damage.

Liberty has a long-term plan to upgrade these two power lines and associated substations so the entire looped system operates at a higher voltage and, as a result, improves reliability. This allows for greater flexibility to transfer load and enhance switching ability reducing the frequency and duration of outages if part of the system is damaged. For more than three years we have worked with federal, state and local agencies to obtain necessary permits, and hope to begin construction on the first phase this year.

While the 625/650 project will result in our system's most significant improvement, we have and will continue to do smaller reliability projects as part of our overall system maintenance.


