## IV. GDRA Board Member Comments:

- Jamie presented a siding product to approve to use in Glenshire. Also updating that he is working with DRC to create approved building materials.
- Peter stated that 2 board members moving in next one to three months. Board agreed to get word out re: positions open and need to fill
- Jamie requested we put word out to get two more members on DRC

#### V. Presentations:

- 1. Annual Financial Review, McClintock Accountancy Corp.
  - Kendall from McClintock presented with power point
  - Q&A with Kendall and Board
- 2. Bill Seline, Fire Chief, Truckee Protection District
  - Bill Seline Presented on Wildfire Preparedness & Truckee Fire Updates
  - Approx 3,000 calls per year, including ambulances
  - 9 of 20 most destructive fires happened in the last year
  - Nevada County is in the very high fire hazard severity zone so doesn't help with insurance
  - Fire season longer in Glenshire than other Truckee areas due to the quick snow melt and longer dryness
  - Prevent Disaster: 1.Fire Prevention: Fuel Management 2.Emergency Response: Nixle, etc. 3. Personal Responsibility: Create defensible space/no outdoor fires, etc.
  - Truckee Fire doing Fuel Reduction
  - Created Community Wildfire Protection Plan: Performing 40 acres of fuel reduction in Glenshire this year. Did 9 acres last year.
  - Brockway Fuel Break project 800 acres Martis area this year
  - New ordinance implemented June 1, 2019: when new escrow, a defensible space inspection is required to be done by Truckee Fire
  - Peter brought up GDRA dovetailing on this to enforce
  - 70% success with inspections where property owners comply
  - 22 of 36 wildfires last year from human cause and 13 from a campfire
  - No Campfires allowed! June November in Truckee (doesn't apply to campgrounds)
  - Jamie recommended to include mandatory timer for gas burners in ordinance
  - Property Insurance: Get defensible space inspection, use local broker, send broker to Firewise USA website.
  - Wildfire documentary Tke High April 3 & 17-do eblast
  - Community Wildfire Mtg 4/24, Town Hall Livestream eblast
  - Nevada Firesafe Council has funding for some expensive tree removals and seniors

- Glenshire would like to get a siren. Bill stated they would try and support this; however, feel it's not as effective as one would think. They are looking at a high/low European siren will tell people where to tune in for emergency message-staff follow up. Thinks this would accomplish same thing and not cost as much.
- Truckee Fire can hold owners accountable for defensible space if it is within 100 feet from another house/garage
- Owner brought up how to handle easements. Bill said it's possible to include these in next grant, including roadside.
