1. Maintain Defensible Space

Defensible space on every property matters toward increasing fire safety for the entire region. Find helpful information at <u>www.truckeefire.org/defensible-space</u>

2. Use Dark Sky Exterior Lighting

Dark skies are one of the reasons many of us live in the mountains and not a city. Town of Truckee and Glenshire have Dark Sky ordinances. Studies have shown that bright lights are harmful to wildlife, effecting feeding, mating and more. Visit <u>www.darksky.org</u> for more information. Less of Our Light, More Star Light!

3. Pick Up Pet Waste At All Times

Pet waste is a polluter of the Glenshire Lake, which flows into the Truckee River. Many streams and drainages flow to the Glenshire Lake, so picking up pet waste on and off trails is important.

4. Keep Control of Pets

Pets chasing wildlife can be very detrimental, especially during nesting and fawning seasons. Keep dogs from roaming and respect use of leashes for their safety and the safety of others. We requests dogs not go on the Glenshire Lake island.

5. No RV Living

Pursuant to GDRA rules and regulations.

6. Contact GDRA Office For Exterior Improvement Approvals

Most exterior improvements require GDRA approval, including but not limited to: Painting / Windows / Sheds / Fences / Additions / Parking Areas / Tree Removal. Some improvements require a Design Review Committee approval, others staff approval

7. Responsible Use of Dumpsters, Bins and Carts

Please contact GDRA staff if you need to use the clubhouse dumpster. Please tie all bags and don't put cardboard or green waste in the dumpster. Please don't put household trash in the clubhouse bear bins or over the dumpster gate. Please help protect wildlife and store recycle carts in an enclosed area until morning of pick up.

8. Respect Your Neighborhood

WILDFIRE SAFETY

Defensible Space | Home Hardening | Fuels Reduction

As 2021 fire season approaches, we can all do our part to help increase fire safety for the entire community. With the help of Glenshire/Devonshire Members and neighboring residents doing a great job on their defensible space work last year, our National FireWise Community designation has been renewed through the end of 2021! We encourage residents to take care of their defensible space early. Great resources are Green Waste Drop-Off Events and Dumpster Rentals, information is listed in this Shire. Also helpful defensible space information can be found on our FireWise® Community page at glenshiredevonshire.com such as Truckee Fire-Defensible Space (includes

list of defensible space contractors) and GDRA Defensible Space Policy. As spelled out in this policy, GDRA staff will begin defensible space inspections throughout the community in late May and plan to re-inspect prior to July 1st, with a goal of defensible space compliance on GDRA properties, for the safety of all. We will of course continue these inspections as needed and feasible throughout the year. To help handle these numerous inspections, we plan to hire seasonal staff; a job listing is posted on our website.

The Association is also starting to provide recommendations and information to Owners on **Wildfire Home Retrofitting.**

We hope you can find time to view "A Wildfire Home Retrofit Guide" found on our FireWise[®] Community website page, that can help people better understand how to prepare homes and communities for wildfire. Immediately below this information is a link to the California Department of Insurance February press release wherein it is stated **Researchers** have referred to community-wide home hardening as "herd immunity" against wildfires in a story in the Los Angeles Times.* Our Firewise Committee continues to research and learn more about the importance of Home Hardening and are excited to highlight this topic in our annual Wildfire Preparedness Workshop (Webinar) planned for some time this June!

Also important toward increasing fire safety is continuing/maintaining **Fuel Reductions on GDRA common space.** Approximately 65 acres (11 parcels) were addressed over the past two years! Volunteer opportunities exist for Members interested.

All of these measures collectively would make a huge impact in wildfire safety in our region. It's not if, it's when. Thank you for doing your part!

Attic and Crawl Space Vents

INSTALLING THE RECOMMENDED MESH SCREENING AND ELIMINATING STORAGE IS CRITICAL TO REDUCING BUILDING IGNITIONS DURING A WILDFIRE.

VENTS IN ATTICS AND CRAWL SPACES

Attic and crawl space vents, and other openings on the vertical wall of a home, serve important functions, including providing ventilation to remove unwanted moisture from these typically unoccupied spaces and oxygen for gas appliances such as hot water heaters and furnaces. Wind-blown embers are the principal cause of building ignition and can readily enter these spaces, which are often hot and dry. Providing air for ventilation, while also keeping out embers can present a dilemma. Dry materials are more easily ignited by embers, so limiting the entry of embers into attic spaces is critical. Adding to the problem are the combustible materials we tend to store in these spaces (e.g., cardboard boxes, old clothes and other combustible materials) because embers accumulate against them and they can be easily ignited.

HOW VENTS FUNCTION

Ventilated attic spaces have openings in two locations. Inlet air comes from vents located in the under-eave area at the edge of your roof. Exiting air leaves through vents located on the roof or at the gable ends of your home. If your home is built over a crawl space, you will typically have vents on each face of your home to provide cross-ventilation. Experiments conducted at the IBHS Research Center demonstrated that regardless of whether a vent had an inlet or outlet function, when wind blows against its face, it is an inlet vent. Therefore, any vented opening on your home should be able to resist the entry of embers. Unvented attic and crawlspace designs are available for some areas of the country. These designs are more easily implemented with new construction. Check with local building code officials to see if this is an option where you live.

USE MESH SCREENING TO REDUCE EMBER ENTRY INTO VENTS

Building codes require vent openings to be covered by corrosion resistant metal screens, which are typically 1/4-inch to keep out rodents. However, research shows that embers can pass through 1/4-inch mesh and ignite combustible materials, particularly smaller materials such as saw dust. Embers also can enter smaller screening, such as 1/16-inch, but cannot easily ignite even the finer fuels; however, this size screening is more easily plugged with wind-blown debris and is easily painted over if you are not careful when re-painting your house. Installing 1/8-inch mesh screening is suggested in wildfire prone areas, as it effectively minimizes the entry of embers. It's important to note that 1/8-inch screening only minimizes the size and number of embers and does not eliminate them entirely; making it very important to reduce what's stored in the attic and crawl space.

BEST CHOICES FOR VENTS TO RESIST EMBER ENTRY:

For (under-eave) inlet vents, opt for a <u>soffited eave</u> design. IBHS research demonstrates that gable end vents and other vent openings are vulnerable to wind-blown embers when the face of the vent is perpendicular to the wind flow, while embers are less likely to pass through vents with a face that is parallel to the wind flow. Therefore, soffited eave construction is preferred to open eave.

For outlet vents, opt for a ridge that is rated to resist wind driven rain. These vents have an external baffle at the vent inlet. Vents that have been approved for use by the <u>California Office of the State Fire</u> <u>Marshal</u>.

Turbine vents also help keep embers out, but you should attach a piece of 1/8-inch mesh to the bottom of the roof sheathing at the opening for the vent.





WILDFIRE RESEARCH FACT SHEET



Reduce the Vulnerability of Your Deck to Wildfire

MANY HOMES LOCATED IN WILDFIRE-PRONE AREAS HAVE ATTACHED DECKS, WHICH CAN POTENTIALLY SPREAD FIRE TO THE HOUSE WHEN IGNITED DURING A WILDFIRE.

A burning deck can ignite siding or break the glass in doors or windows, allowing fire to gain entry into the house. Consequently, making decks less vulnerable to wildfire also makes your house less vulnerable. Reducing the deck's vulnerability requires an approach that focuses on the materials and design features used to build the deck, and creating a noncombustible zone around and under the deck.

EMBER EXPOSURE AND IGNITION

Walking surfaces of decks are either solid surface or constructed using deck boards (with between board gaps). Solid surface decks are commonly light weight concrete or tile. Combustible deck board types include: solid wood and wood-plastic composites (these products are more widely used than noncombustible deck boards). Noncombustible deck board types include: metal and fiber cement.

Recent testing at the IBHS Research Center showed embers mostly lodge between deck board gaps and where deck boards rest on joists. Embers can accumulate and potentially ignite decking and combustible joists. Embers can also fall through board gaps and land on materials stored beneath the deck. It's critical to remove all combustible materials from the under-deck area to minimize the opportunity for ignitions; where resulting flames would impinge on the decking (some wood-plastic decking products are vulnerable to flaming exposures).

IBHS tests also showed that even without vegetative debris in between deck gaps, medium density softwood decking products, such as redwood or western redcedar are vulnerable to ember ignitions. Most wood-plastic composites, along with higher density tropical hardwood, and fire-retardant treated decking products are less vulnerable to embers. The vulnerability to embers in these locations is a reminder to remove debris that accumulates in these areas.

BUILDING CODE REQUIREMENTS

The International Wildland Urban Interface Building Code (IWUIC) and the California Building Code are the most commonly referenced construction codes for wildfire-prone areas; both include requirements that focus on the walking surfaces of decks. Noncombustible products are allowed by both codes.

The California Code provides provisions for accepting combustible decking products. These types of products are more commonly used by homeowners living in wildfire-prone areas across the country. Their requirement governs the amount of heat released when combustible decking is ignited by a gas burner. This mimics burning debris that could be located under the deck, or burning vegetation impinging on the underside of the deck, but does not mimic ember exposure. The IWUIC prohibits common combustible deck boards with the exception of fire-retardant treated decking (rated for outdoor exposure) and other materials

RECOMMENDATIONS FOR YOUR DECK:

Combustible materials should not be stored beneath decks. This will effectively create a noncombustible zone under the entire footprint of the deck.

Routinely remove debris that accumulates in between deck board gaps and debris that can accumulate at the intersection between the deck and house.

If the deck is a non-fire-retardant treated softwood deck, consider removing and replacing deck boards within a few feet of the house. Be careful to match the deck board thickness.



When building new decks, select deck boards that comply with the CaliforniaBuilding Code requirements. If using wood joists, cover the top and part of the sides with a foil-faced bitumen tape product.

that meet the requirements of an Ignition Resistant Material. However, as of this date, no other materials meet these requirements. The IWUIC allows an enclosed deck option that uses a horizontal construction attached to the bottom of the deck joists. This option should only be used with a solid surface deck. Using this option with deck boards (and the associated gaps), will cause moisture-related degradation problems (corrosion of fasteners and wood rot). Water from rain or melting snow will easily get into the enclosed space and will have a much harder time getting out.

Important To Maintain Your Decks For Safety

Decks add a great deal to quality of life, but we encourage their maintenance or upgrade consistent with current understanding of home resistance to wildfire and urban fire embers. GDRA is working with the Town and knowledgeable contractors to identify materials and procedures for some upgrades, specifically the replacement of one or two courses of exterior wall-adjacent deck boards with non-combustible alternatives. As stated on the Town website, some minor repairs and maintenance have not been subject to building permit requirements, and we're also working to simplify the process for any that are. Stay tuned!



This Jeffrey pine at Glenshire and Dorchester is about 3.5 feet in diameter at breast height (dbh, the standard height above the ground to measure diameter). This tree is probably 100-200 years old and will likely be preserved, with underlying fuel and limbs up to 15 feet removed, due to collaboration between Town staff, GDRA, and other community members.



Town of Truckee Roadway Vegetation Project

The Town commenced its 2021 work on this project on April 19th in the Glenshire neighborhood. This is a continuation of a two year effort that includes work in the Tahoe Donner, Glenshire, Sierra Meadows, and Prosser Lakeview neighborhoods. The work began in the Tahoe Donner neighborhood in the summer of 2020, where vegetation removal was completed on 61 centerline miles of roadsides to a distance of 15 feet from the edge of the roadways. This year's project includes removal of vegetation along 42 centerline miles of roadsides within 10 feet of the edge of the roadways in Glenshire, Sierra Meadows, Prosser Lakeview, and the peripherals of Tahoe Donner. The goals of the project are to

- increase wildfire resiliency by reducing the chance of an ember- or spark- caused ignition spreading and increasing the width of the fire break created by the road;
- improve evacuation safety and emergency vehicle ingress in the event of a wildfire;
- improve snow storage areas and the ability of Town Public Works to provide efficient snow removal; and
- improve roadside safety.

Based on the advanced communication from the Town, more than 300 residents in the project neighborhoods, including GDRA staff and a Board member, contacted staff with questions and concerns. Community engagement and exchange is part of the public process and, based on this engagement, the scale of this year's project was adjusted. The project scope has been revised to include removal of all vegetation within 10 feet of roadways except for groundcover vegetation less than 18 inches in height, but preserving trees larger than 24 inches in diameter at breast height (limbed to 15 feet), and vegetation within the median islands in the Sierra Meadows neighborhood.

The interactive project map showing completed, in progress, imminent (next two weeks), and other planned roadways can be found at www.townoftruckee.com (search for 2021 Roadway Vegetation Management Project or use the live link on the GDRA eBlast). The Town's Contractor should complete treatment of the roadways in Glenshire by early June and will move into Sierra Meadows at that time followed by Prosser Lakeview in August. These are tentative schedules based on current Contractor efficiencies and may be updated as the project progresses.

Residents who contacted Thom Ravey were allowed until May 14 to complete relocation of their plants outside the 10 foot zone. We remind everyone that state law requires that anyone planning to undertake any excavation at all, which includes digging to relocate plants, must call 811 to get the locations of utilities marked, two full business days prior to the day of excavation.

We wish to remind all members that the Town right-of-way is not part of the adjoining parcel, even where a driveway has been built pursuant to an encroachment permit, subject to strict limitations. Plantings and other permanent objects other than mailboxes adjacent to driveways should not be installed in the right-of-way, with the exception of low groundcover and seasonal herbaceous ornamental plants. In the course of evaluating this Town project, GDRA personnel examined miles of roads in the Glenshire area and found many instances of dense plantings of highly flammable vegetation such as junipers and small conifer trees which are inadvisable whether in the right-of-way or within the Owner's parcel, even closer to structures.

We urge every owner to review his or her parcel for consistency with defensible space recommendations and laws. Town staff has indicated that although the project Contractor will not be working beyond the 10 foot zone, residents who wish to thin small trees a few feet further from the pavement edge than that, and who do this prior to the project's work on their street, may leave the material for chipping and removal by the Contractor.





ELECTRIC SAFETY OUTSIDE

Our lives are powered by electricity, now more than ever. From lighting to heating/ cooling to cooking to computing to entertainment and even transportation, electricity is everywhere, and we are dependent on it. However, electricity is a powerful force that must be treated and approached with caution.

According to the National Center for Biotechnology Information, there are approximately 1,000 electrical injuryrelated deaths and at least 30,000 shock injuries per year in the United States. It is important to be mindful of the danger posed by electricity and electric infrastructure and take steps to avoid harm to yourself and others.

Outside Electrical Safety

There are four primary areas outdoors to be cautious of: substations, overhead powerlines, underground electric facilities, and generators.

Substations

Substations are facilities where higher voltage electricity brought in from transmission lines is reduced to lower voltage electricity that can be used by homes and businesses. These facilities are fenced in with "Danger High Voltage" signs posted all around. If a ball, Frisbee, balloon, or other object gets lost behind the fence, leave it and do NOT try to retrieve it. Stay clear of substations.

Power Lines

Power lines are the most visible of the power infrastructure and are particularly dangerous because of the high-voltage electricity they carry. Always maintain a minimum distance of 10 feet from power lines, including objects such as ladders, lumber, and tools. Never tie anything to a power line. Keep kites, model airplanes, drones, and other objects clear of overhead lines. If a power line is hanging



or on the ground, assume it is energized, stay clear, and call 9-1-1 immediately.

Underground Electric Infrastructure

Although most electric infrastructure consists of wires and poles above ground and in plain view, there is some electrical infrastructure that is underground and out of sight. Call 8-1-1 before digging to avoid potential underground electricity.

Generators

Some people prepare for the possibility of a power outage by purchasing an electric generator as a standby system. A generator may help power lights and other necessary appliances around the home or business until power is restored. However, generators can pose a serious safety hazard if not used and installed according to the manufacturer's instructions.

Permanent Standby Generator Safety

• Only a qualified professional, such as a licensed electrical contractor, should install a permanent standby generator.





- A double-pole, double-throw transfer switch is the recommended device to keep a generator from back-feeding into Liberty's system. This switch also prevents Liberty from re-energizing your building wiring while your generator is running, protecting your generator, wiring, appliances, and equipment from damage once power is restored.
- Follow all applicable building codes in your area, and have your wiring inspected by the city or county building department.
- If you already have a permanent standby generator installed, but you're not sure it's installed correctly, call your local city or county building department to have it inspected, or

call a licensed electrical contractor for assistance.

 Call and notify your local Liberty office once your backup system is installed. This allows work crews to be on the alert for possible generators in service if they are working on a power outage in your neighborhood. A power company employee may ask to check your transfer switch for safety prior to performing work.

Portable Generator Safety. Portable generators are designed to be temporarily connected to selected appliances or lights. These generators should never be connected directly to your building's wiring system.

• Before you use your generator, thoroughly read and understand all of

the manufacturer's instructions. If you have any questions concerning the safe operation of the generator, call the dealer before operating the unit.

- Be sure the total electric load on your generator won't exceed the manufacturer's rating.
- Always locate your generator where its exhaust will vent safely, NOT indoors or in a garage. Generator exhaust can be deadly.
- Never plug a generator into a household outlet or other home wiring. Use an extension cord to plug lights and appliances directly into the generator, but always be sure to inspect the cord for damage before using.
- Be sure the extension cord is the proper wire size to carry the electric load essential for your needs during a power outage. Overloading an extension cord may lead it to overheat and pose a fire hazard.
- Keep all extension cords out of the way to avoid tripping hazards. Never run cords under rugs or carpeting where a damaged spot could go unnoticed. Heat can build up in such areas and pose a fire hazard.

Safety is a top priority for Liberty in providing reliable power service. We encourage our customers to make electrical safety a top priority, too.

BACK IN TOWN

Please slow down. The deer are back in town.

There have been many deer/vehicle collisions on Glenshire Drive and Hirschdale Road over the past few years! **Please be aware!**

The Glenshire region serves as a large part of the traditional deer migration corridor used by the Verdi sub-unit of the Loyalton-Truckee Mule Deer Herd, for their winter and summer migration. Driving through this forested region, you would assume there were deer everywhere, but in fact only a single herd remains and their numbers are declining. Protecting habitat and limiting threats to this herd, especially along the migration corridor, is considered critical by many biologists, and it is up to us to help.

Deer are very active in our region spring through fall. They tend to arrive in April/

May and start migrating back to their wintering grounds October through December.

Factors in the decline of deer populations include habitat loss or change, predation (by both human and wildlife predators), vehicle collisions, and disturbance of doe-fawn pairs by human-related factors including uncontrolled dogs.

We can all help in efforts to preserve this herd by driving carefully while watching for deer on sides of the roadways. These efforts will also help with increasing the safety of ourselves and other wildlife.

info@glenshiredevonshire.com. GDRA staff will normally provide approval status within 7-10 business days. NOTE: Exterior paint colors should be soft (not bright) earth tones, and may not be solid black, white, red, yellow, or blue, except in use of trim (white discouraged). Garage doors must be painted to match or compliment house color. Staff may require review by the Design Review Committee on a case-by-case basis. Building a shed, fence, garage, home addition or removing a tree, etc.?

Exterior Improvements, such as but not limited to, sheds, fences, garages, additions and most tree removals need to go through the Design Review Committee (DRC) approval process. A homeowner's association (HOA) is an organization in a planned community or condominium building that makes and enforces rules for the properties and its residents by means of covenants, conditions, and restrictions (CC&Rs) that are, in effect, legally a part of the deed to each individual parcel. The CC&Rs are supplemented by Association rules and bylaws that collectively govern residents and the Association board and staff operations.

Each owner of a parcel also has part ownership of the mutualbenefit nonprofit HOA Corporation, which is the entity that owns the common areas. (In some other common interest developments, each unit owner is also a direct part owner of common areas.) Another primary purpose of an HOA is to manage a neighborhood's common areas such as open space, buildings, and other facilities; and to manage the corporation's business and financial affairs prudently on behalf of the members who fund it by means of their dues.

A mutual-benefit nonprofit is a type of nonprofit that works for the benefit of a select group of members rather than for the general public. Contrary to a misunderstanding that is sometimes stated or implied, the restriction of the use of GDRA properties and amenities to members, tenants of members, and guests while accompanied by members is not an optional or recent change; this limitation to our private use has always existed in

the Association governing documents. It's also the case for nearly all HOAs in our area and probably throughout California. Likewise, despite the open appearance of our common spaces, these are not public parks or land trust owned lands that are open to public use; our open space areas are also limited to private use of members and their accompanying guests. The legal considerations, insurance issues, and costs of opening our common areas to use by the general public would be considerable.

A Board of Directors is a requirement for an HOA, or indeed any corporation, to function legally. These elected volunteer Directors are responsible for all operations of the association and ensuring the community governing documents are followed and enforced. In doing so, the Board also must comply with the state business code and Davis-Stirling Common Interest Development Act, which specifically regulates HOAs in a way that is analogous (but not identical) to the state laws that govern the actions of public elected bodies like our Town Council.

Fireworks And Bottle Rockets Are Illegal

Per the NFPA, Fireworks start an average of 18,500 fires per year, including 1,300 structure fires, 300 vehicle fires, and 16,900 wildland fires. In 2018, these fires caused an average of three deaths, 40 civilian injuries, and an average of \$43 million in direct property damage.

All fireworks are banned in Nevada and Placer County, except permitted public display fireworks that are issued a permit by the local fire administration, authority having jurisdiction (TFPD). Town of Truckee Ordinance 2015-05 amending the municipal

code Chapter 9 - section 9.15.050 prohibits fireworks within the town limits, except for permitted public display fireworks that are permitted by TFPD. This ban includes Safe & Sane fireworks.

Residents can report illegal fireworks by calling the Nevada County Sheriff Non-emergency Dispatch Line 530.550.2320. Truckee Police Department will be the responding unit within the town limits. The penalty for possession and use per the municipal code is a misdemeanor that could result in a fine or even jail time.

If you encounter a bear in your home:

Do not approach the bear.

Remove yourself from danger.

When safe, call 911.

Do not block any exits that the bear may use to escape.

If you encounter a bear in your yard:

Slowly back away. DO NOT approach the bear.

Allow the bear plenty of room to pass or withdraw.

Once you are a safe distance away, encourage the bear to leave by banging pots and pans or making other loud noises.



Bears are attracted to anything that is edible or smelly. Use the checklist below to help bear-proof your home:

Garbage problems can be solved with the purchase and correct use of a bear-proof garbage container. Save money by sharing one with a neighbor! For bear-proof containers and where to buy them visit www.dfg.ca.gov/keepmewild/products.html.

Wait to put trash out until the morning of collection day.

- Don't leave trash, groceries or animal feed in your car.
- Keep garbage cans clean and deodorize them with bleach or ammonia.
- Harvest fruit off trees as soon as it is ripe, and promptly collect fruit that falls.
- Avoid using bird feeders. They are a powerful attractant.

- Don't leave any scented products outside, even nonfood items such as suntan lotion, insect repellent, soap or candles.
- Keep barbecue grills clean.
- Keep pet food and pets inside.
- Securely block access to potential hibernation sites such as crawl spaces under decks and buildings.
- Keep doors and windows closed and locked. Scents can lure bears inside.
- Consider installing motion-detector alarms, electric fencing or motion-activated sprinklers.
- Remove all food from homes and cabins that will be unoccupied for an extended period of time.

Feeding deer is dead wrong. It's also against the law.

Allowing deer access to your garden and landscaping, or intentionally feeding deer, can be deadly. Wild animals naturally fear people, keep a distance, and will not bother you, so long as they remain truly wild. But if they become accustomed to humans, their natural ways are ruined. Their normal wildness and fear of humans is lost. That's when conflicts occur.

Keep them wild.

- Never intentionally feed deer
- Landscape with deer-resistant plants (contact your nursery for ideas)
- · Enclose gardens with eight-foot fencing
- Pick up fallen tree fruit
- Install motion-sensitive lighting around the house and garden
- Consider using commercially prepared dee
