



Things have changed

- Last 20 years increasingly devastating fire seasons in California
 - 12 of the largest fires occurred since 2017 (9 of these in the last 2 years)
 - 13 of the most destructive fires occurred since 2017
- Lack of natural fires = build up of fuel, overgrowth, unnaturally dense forests
- More people have moved to the WUI
- Climate change coupled with overgrowth
 - stressing trees leading to dryness, bark beetle, death and increased fire intensity
- More residents and visitors
- Wildfire intensity has increased
- Multiple recent, nearby large fires, destruction, and even death.



What is Truckee Doing? → Wildfire Prevention Tax Measure

Measure T: Voter-Approved Funding for Wildfire Prevention

- 95% of voters "wildfire is most important issue"
- 79% support by Truckee Fire Voters, "Yes on Measure T"
 - \$179/parcel property tax
 - Generates a \$4 million Community Wildfire Prevention Fund
 - Funds & programs are managed by Truckee Fire Protection District
- Programs and Benefits: Defensible space inspections, green waste disposal, CWPP update, forest management & fuels reduction, dead tree fund, community grants, evacuation, home hardening...
- Fiscal Accountability Community Oversight Committee

Defensible Space Around Homes

What should I do?

Zone 0 – Ember Resistant Zone

Science and wildfire losses have proven this zone to be the most important

- Remove pine needles & combustible items
- Move firewood 30' away from house
- Remove all dead vegetation
- Clean under decks
- Limb trees away from home

Zone 1 & 2 Defensible Space

- Limb trees up at least 6 feet (prevent laddering)
- Remove dead vegetation
- Space trees, bushes and plants

What is Truckee Fire Doing?

Truckee Fire hired 4 Defensible Space Specialists that are available to walk properties with homeowners and educate them on defensible space and home hardening.

Truckee Fire will also be inspecting certain neighborhoods each year to increase the total number of annual inspections, education, and accountability to meet fire safety requirements.

Defensible Space Inspections

Goals

- Educate residents on the importance of defensible space
- Provide info on programs available to assist
- Increase wildfire resilience in the community

Work Plans

- Truckee Fire will be inspecting 1/3 of the Association each year
- Starting with inspecting homes accessed from Donnington Ln
- Homes near the bluffs were inspected in July following the Butterfield Fire

DEFENSIBLE SPACE IS REQUIRED BY LAW



ZONE 0: 0'- 5'

This is the most important defensible space zone. Keep your home and the first 5' noncombustible and ember-resistant.

ZONE 2: 30'- 100'

Extends from 30' to at least 100', or to the property line. Remove dead vegetation and create spacing between live vegetation.

Green Waste Disposal

Truckee Fire is offering free green waste disposal options to help you get defensible space work done. Go to truckeefire.org/greenwaste for more info and to sign up!

ZONE 1: 5'-30'

Think "Lean, Clean and Green". Remove dead vegetation and ladder fuels and ensure there is adequate spacing between shrubs and trees.

Home Hardening

Embers are the most common cause of home ignitions during wildfires. Simple and often inexpensive design and material retrofits can help protect your home.

Online Report

A recent inspection was completed that provides suggestions and requirements for defensible space and home hardening, plus info on evacuation and green waste disposal!

Affordable Green Waste Disposal Options

don't be fuel to the fire!

Free Curbside Pick-Up & Haul Away

- A crew will drive up in a large dump truck to pick-up & haul away defensible space vegetation
- All eligible material is picked-up and hauled away



- A chipping crew will drive up with a truck and trailered chipper to chip defensible space vegetation
- Chips will broadcasted back onto the property or left in a pile



- Truckee Fire will reimburse up to \$75 towards the cost of a request a 6-yard 6 Yard Green Waste Dumpster Rental
- Requests made through TTSD & paid receipts submitted to
 Truckee Fire *Dumpsters available through end of October each year



Community Wildfire Protection Plan

2022 CWPP Update

- With passing of Measure T, Truckee
 Fire Protection District will update the
 2016 CWPP.
- The CWPP update will capture large land fuel reduction, and other wildfire prevention projects in the WUI
- 20+ agencies, land managers, and the community will be engaged and have input
- The CWPP will provide a prioritized list of lands in the WUI that need forestry and fuel reduction treatment
- Serves as a guide for Measure T funded forestry, fuels, and wildfire prevention projects and programs
